Dan Atkins, Managing Director of Shaper Group has many years experience presenting to a range of audiences on climate change and sustainability related topics both in Australia and abroad. Prior to forming the Shaper Group Dan was Project General Manager of Environmental Affairs for Toyota Australia, where he headed up both the corporate and manufacturing environmental groups. He was founder and leader of Deloitte Touche Tohmatsu's Environmental Services Group in Australia and spent two and half years managing Deloitte's Global Centre of Excellence for Environmental and Sustainability Services in Copenhagen, Denmark. Dan is former co-chair of the Reference Group for the Victorian Commissioner of Environmental Sustainability and is a former member of the South Australian Premier's Round Table on Sustainability.
